SUMMARY

Under the general supervision of the Service Manager, the Oil Service Technician installs, repairs, and services customer systems.

PRIMARY FUNCTIONS

The Oil Service Technician is primarily responsible for the following functions:

- Installs oil burners, tanks, and furnaces for new and existing customers.
- Performs service calls and preventative maintenance on existing systems.
- Performs annual cleanings and tune-ups on systems.
- Primes systems following a "no heat" call.
- Completes systems inspections and repairs.
- Responds to emergency calls as necessary.
- Provides mentorship and guidance to Apprentice.
- Performs all other similar duties as required.

QUALIFICATIONS

Required:

- High school degree or equivalent.
- Current Oil Burner Service Technician license.
- 3-5 years prior field experience.
- Valid driver's license.
- Ability to work extended hours as necessary, especially during peak demand seasons.

Preferred:

- CDL A or B with HazMat and Tanker endorsements.
- Current DOT medical card.
- Prior experience with propane and gas systems.
- Bilingual in English or Spanish.
